### --EAA 42 Trade Show offers aircraft building info to locals--

The 2010 Alaska Airmen's Association Trade Show and Convention was the biggest and the best so far according to its participants and vendors. EAA Chapter 42 was there to explain homebuilt aircraft information and what the Chapter has to offer.

This year's May 1-2 annual Trade Show drew estimates from 21,000 to 30,000 people who attended the two day show that also hosted over 270 vendors.

EAA Chapter 42 had their booth in the usual spot in the Southeast corner of the FedEx hangar. Jim Moss, John Davis, Walter Yankauskas along with Mike and Grace Whedbee and Jerry Jundt volunteered to

answer questions.

"The Airmen's couldn't do this with out the support of FedEx and UPS offering the hangar and ramp space, said Dee Hanson, executive director of the Alaska Airmen's Association. "We want to thank them for working with us and working together, something you won't see very often as business competitors."

Also acting as sponsors and supporting the show were Airline Support, ShamanTraffic Control, Eye Cue Productions, Mirror Studios, Westbrook Advertising, Syntax Studios, Denali Brewing and Ted Stevens Anchorage International Airport.

Considered the largest aviation event in the state, this is the 13<sup>th</sup> consecutive year that the Alaska Airmen's Association has held the Trade Show and Convention at the FedEx Maintenance hangar

at Ted Stevens Anchorage International Airport.

As an event that is free to the spectators a real count of how many people actually attend is open for discussion, according to Hanson.

Vendors from all over Alaska and the Lower 48 also faired well with their sales, according to Hanson.

"According to our vendor surveys there were as many as six businesses that sold over \$50,000 and several broke the \$100,000 level," said Hanson.

The two days offered more than sales it offered a chance for vendors to network and see friends and acquaintances from all over Alaska.

Also displaying and participating were the students and parents of the "Build-a-Plane project

Ticket number 5480 was drawn which belonged to Jim Sitkiewicz, of Anchorage who raced to the FedEx hangar shortly after the drawing with his wife Laurie to claim the special PA-18 aircraft refurbished by Dan's Aircraft Repair of Merrill Field.

**Update on EPA's AVgas ANPRM**

Alaska aviation industry leaders met this month to create a strategy for the addressing the EPA's Advanced Notice of Proposed Rule Making on the 100 Low Lead Avgas issue.

The EPA has asked industry and user groups nationwide to respond to a Notice of Proposed Rule Making over curtailing the use of, finding a new fuel, or the possibilities of new diesel engines coming online to replace 100 Low Lead fuel. Comments on this effort are meant to guide the EPA in making a determination on how to proceed.

Fourteen people representing aviation concerns statewide met on May 19 at Evert's Air Cargo in Anchorage and agreed to ask the Alaska Congressional Delegation to approach the EPA to extend the June 28 deadline for NPRM comments on the issue.

In the meantime Chevron announced that it will no longer provide fuel to its General Aviation distributors in Alaska, and will only offer Avgas to commercial entities using it.

Additional meetings will be held this month to address commercial concerns on the proposal. For more information go to:
